

## **Agreement and Release of Liability**

1. **Voluntary Participation** I am freely and voluntarily choosing to attend and participate in the events hosted by Interior Kink Fest (herein referred to as IKF) and to view and/or participate in activities that I know are adult oriented and sexually explicit. These activities may include acts of domination, submission, bondage, discipline, sadism and masochism, and/or other explicit and extreme sexual fetishes and activities including, but not limited to spanking, paddling, whipping, waxing, piercing, fire play, knife play, edge play, blood play, bondage, suspension, fisting and other oral, vaginal and anal penetration. I understand that these activities involve certain risks including, but not limited to, the possible negligent or reckless conduct of other participants.
2. **Assumption of Risk** I am aware that some of these activities are considered hazardous. I am voluntarily participating in or viewing these activities with full knowledge of the dangers involved. I accept and I assume full responsibility for any and all risks of property damage, emotional distress, personal injury or death.
3. **Liability Release** As consideration for being permitted by IKF to enter the event, and to view and/or participate in these activities, and to use the facilities and/or equipment being provided, I agree that neither I nor anyone through me or on my behalf will make any claim against me or sue IKF or anyone affiliated with, but not limited to IKF, it's officers, directors, members, agents, employees, volunteers, promoters, sponsors, and contractors and including but not limited to, the owners, lessors or suppliers of the premises and the owners, lessors and suppliers of any of the equipment being used in connection with the event, for any injury or damage suffered by me at any time during my presence at the event or as a result of my participation in any activities at the event. I hereby release, waive and forever discharge them, their heirs, administrators, executors and assigns from any and all claims, demand, actions or rights of action, of whatever kind of nature, either in law or in equity, arising from or by reason of my attendance at or participation in the event or activities.
4. **Indemnity and Hold Harmless** I agree to indemnify and hold harmless, IKF, and those individuals and entities described in Paragraph 3 above, from any loss, liability, injury, damage or cost that they may incur due to my presence or my actions at the event, whether caused by my negligence or otherwise.
5. **Law Enforcement and Postal Agencies** I am not acting in the capacity of, as a member of or under the direction of, and law enforcement or postal agency. I am not attending any of these events for the purpose of entrapment or to gather information and/or testimony that would lead to or further the arrest or prosecution of these events, the owners of the premises, or any individual attending these events.
6. **Media** I am not acting in the capacity of, as a member of, or under the direction of, any media agency. I will not publish or submit for any kind of publication information, writings, photographs, audio recordings, video recordings, or any other records of activities regarding these events, without the expressed approval of it's organizers.
7. **Knowing and Voluntary Execution** I have carefully read this document and fully understand its contents. I am aware that is a release of liability and a contract between me and IKF and that I am giving up many legal rights and remedies by signing it.
